AVAX DEVELOPMENT Single Member S.A., with its headquarters at 9, Fragoklissias Street, Marousi, 151 25, as Data Controller, fully complies with the provisions of the General Data Protection Regulation (EU) 2016/679 (GDPR or GDPR) and Law No. 4624/2019 for the protection of personal data.

This Information Notice concerns and applies to the personal data of prospective employees in the context of submitting CVs to find a job at AVAX DEVELOPMENT Single Member S.A.,

Sources of the Data

Information that you actively provide to us when applying for a job your participation in an interview, completing an assessment, sending an e-mail or calling us.

We may receive information from third parties such as:

- 1.From employment agencies
- 2.From publicly available sources, such as the company's website, internet searches or social media platforms and business and employment-oriented websites such as LinkedIn. For the avoidance of doubt, data contained in social networks or websites that do not have a business and employment context are not considered as professional social media data and are therefore not collected and processed by us.

Personal Data

The information we may collect is:

- information you provide to us in your candidate profile, job application, including full name, contact details, CV, additional documents, work experience, qualifications and skills
- information about your visits to our offices and attendance at events
- information collected as part of the monitoring of your recruitment process, e.g. interviews and assessments
- information you give us in the calls you make to us or emails you send to us
- information about your preferences, interests and career aspirations

We do not ask you to provide us with special categories of personal data (i.e. information about racial origin, political opinions, religious or philosophical beliefs, health or sexual orientation), except as expressly required or permitted by law in a particular case. In case you provide us with special categories of personal data, you expressly consent to the processing of this data as defined in this notice.

Scope

The information is used for the following purposes:

- 1. To conduct identity, selection of the position, employment history verification, qualifications, experience.
- 2. Candidate screening and background check during conducting recruitment and selection, including interviews, assessments, selection, job offer and benefits (where applicable)

3. Pre-employment management, including preparation of contractual and non-contractual documents and arranging system and building access.

Legal Basis

The personal data in your application will be processed exclusively for the purpose of recruitment for the specific position.

The legal basis for such processing is Article 6(1)(b) of the GDPR in conjunction with Article 27(1) of Law 4624/2019 on the protection of personal data.

Processing for any additional purposes, for example inclusion in a group of candidates or on a list for future vacancies, is only carried out with your consent in accordance with Article 6(1)(a) of the GDPR.

Recipients

For the processing of personal data, we may use processors, such as companies that provide CV management software systems.

We share information about you with others only in accordance with applicable law. Thus, where the law requires your consent, we will first ask for it e.g. The recruitment process for certain job offers may require your voluntary participation in the assessment, selection or similar processes carried out by third parties. In such cases, we shall inform you about the processes and recipients before transferring your data to third parties.

The recipients of your CV or data may also be group companies.

Transfer of personal data outside the EEA

Your personal data may be transferred to third countries (i.e. countries outside the European Economic Area). In such case, the transfer will be either on the basis of European Commission adequacy decisions or where one or more legal bases are in compliance with GDPR, including your consent.

Data security
